Regions Bank, as Registrar/Trustee, for the Series 2023 Bonds, will cause the Series 2023 Bonds to be delivered to Depository Trust Company (DTC) on August 10, 2023 through DTC's Fast Automated Securities Transfer ("FAST") Program.
